#### **Objectives**

The RIOS project aims firstly at identifying the research and development needs for oiled wildlife response and preparedness and secondly to develop a European Action Plan that proposes further steps to enhance activities in this emerging field of research.

The Action Plan is aiming to be a strategic document which will list the priorities, proposed activities and future projects. The Action Plan is the main delivery of the RIOS project and will be submitted to the European Commission.

The European Commission may consider the Action Plan in the further development of the European Research Policy and, in particular, in orienting the future Research Framework Programmes to better meet the needs of this new field of Research and Development.

A possible spin-off the RIOS project could be that future Calls for project-funding in the 7<sup>th</sup> Framework Programme (FP7) will be dedicated to the area of oiled wildlife, which would be an interesting development and providing access to considerable sources of funding.











### **Partnership**

The activities of the RIOS project are divided into clearly defined work packages, including:


- 1. Providing a state-of-the-art overview and the identification of research priorities with the help of the expert group:

#### **Forthcoming Activities**

The main forthcoming activity is the RIOS-Workshop at Zoomarine, in Albufeira (Portugal).

At the workshop, the whole field of oiled wildlife response and preparedness will be reviewed by a number of invited experts. The workshop will offer a platform for discussion with all interested stakeholders. The main objective of the workshop is the identification of research and development needs. At the workshop project ideas can be exchanged and new consortiums for new projects could be formed. The RIOS consortium will facilitate these discussions and the forming of these consortiums.

The workshop, offers a unique opportunity for individuals and organisations (who are actively involved in the field of oiled wildlife response and rehabilitation) to meet colleagues from other countries and backgrounds and to contribute to the identification of the research priorities.

The target audience for the RIOS workshop are scientists, rehabilitators, veterinarians, national authority officials, NGO, and other professionals in the field of oiled wildlife response and preparedness.
